- You're at least 21 years of age
- Possess a current, full and unrestricted Australian Light Rigid Driver Licence/Endorsement (as a minimum). Learners (trainee instructors) must hold the licence/endorsement pertinent to the relevant vehicle category being: Light Rigid, Medium Rigid, Heavy Rigid, Heavy Combination or Multi-Combination.
- Fulfil all of the relevant state or territory regulatory requirements.
- The instructor's language, literacy and numeracy skills are expected to be equivalent to level 3 of the National Reporting System, which identifies adult English language, literacy and numeracy language indicators of competence.
- RMS requirement for New Instructors a Letter of Eligibility from RMS
- Working with Children check
- Trainers must at a minimum hold TAE40110 Certificate IV in Training and Assessment
